Based on the EG-approval WVTA takes care of all necessary steps to ensure a customer friendly local registration including CoC creation and printing, IVI file creation, printing of local documents (e.g. ZBII for DE), ...

For this purpose WVTA has developed (and is constantly improving) software that enables the registration of vehicles in respective country-specific databases, and that the employees have the know-how and authorisation to run their system correctly. To realise this we have developed interfaces and processing routines which have been adapted to the specific country and manufacturer, and working closely with the customer and country authorities.

We believe in creating transparent working processes for our customers. This helps to smooth workflows, saves structure costs and benefits local dealers.

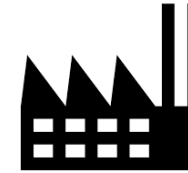
- **EREG Editor**
 - Our EREG Editor software was developed to create Initial Vehicle Information (IVI) files, and was designed to be adapted to each customer's requirements for their specific country meaning it is compatible for use across Europe.
This software also covers vehicle classes, typically O, M and L (trailers and semi-trailers, cars, lorries and vans) and the software can accommodate further class types on request.
- **CoC creation**
 - Our EREG Editor service takes care of creating your vehicle's Certificate of Conformity, and our service includes printing and posting your documents directly to you if required.
- **Registration in European databases**
 - WVTA will oversee data management and vehicle registration of your vehicle for your specific country. We most often work with databases in Austria, Germany, Spain, Italy, France and Belgium, and will work with all European countries.
- **Support in correspondence with authorities**
 - We will mediate with the relevant local authority to ensure a hassle-free process and to solve any potential problems during data registration and certification.

Based on the prepared vehicle type data WVTa is creating files and documents for specific european countries. If local representatives are needed and the customer does not have local dealers, WVTa works with partners.

Solutions for new countries can be worked out by WVTa on demand including clarification with the government/ministry
